- Rebate is equal to \$36 for an individual plan or \$72 for a family plan (regardless of number of lines), which may or may not equal the actual activation fee assessed by your carrier.
- Rebate will be in the form of a mailed check or credit to a PayPal account (submitter's option), not a credit to the wireless account associated with the rebate request.
- Limit one rebate per order ID.
- Service deactivated prior to rebate processing is ineligible for any rebate, regardless of activation fees paid. Deactivation includes any situation where the account number initially assigned by your wireless carrier is not active.
- We are not responsible for late, lost, damaged, misdirected, illegible, or postage-due requests.
- Offer valid only in the United States.

- Limit one rebate form per envelope. All required documentation must accompany the rebate form, in a single envelope.
- Rebate request must be postmarked by August 31, 2009.
